

## SIP, SMOKE, AND SUNSHINE: CAMPAIGN RULES

- 1. Agreement to Rules:** By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements.
